# SHIPPING NOTICE 05/2011 (Rev 2)

## ISSUE OF ENDORSEMENTS ATTESTING TO THE RECOGNITION OF A CERTIFICATE OF COMPETENCY

**To:** OWNERS, MANAGERS, CHARTERERS, CREWING AGENCIES AND MASTERS OF CAYMAN ISLANDS SHIPS (INCLUDING PRIVATE AND COMMERCIAL YACHTS).

## 1. BACKGROUND

- 1.1 In accordance with the International Convention on Standards of Training, Certification and Watchkeeping (STCW 95<sup>1</sup>), officers onboard a Cayman Islands ship are required to hold a Certificate of Competency (CoC) issued in accordance with STCW 95 from a country whose standards of competency and training are considered to be equivalent to those of the United Kingdom.
- 1.2 In accordance with regulation I/10 of STCW 95, holders of such a CoC also require an endorsement from the Cayman Islands Shipping Registry attesting to the acceptance of their CoC.
- 1.2 This Shipping Notice updates the list of countries who's Certificates of Competency are considered acceptable for service as an officer on a Cayman Islands ship.

#### 2. LIST OF COUNTRIES

2.1 Certificates of Competency issued by the following countries are considered acceptable for service as an officer on a Cayman Islands ship.

2.2 This list of countries will be updated from time to time and changes will be circulated by the reissue of this Shipping Notice.

## 3. CERTIFICATES OF MEDICAL FITNESS

- 3.1 In accordance with regulation 4 of the Merchant Shipping (Medical Examinations) Regulations, 2002, all seafarers serving on Cayman Islands ships are required to hold a valid medical certificate.
- 3.2 Medical certificates issued by, or on behalf of, a country listed below are considered acceptable for service onboard Cayman Islands ships. Such certificates should be issued in accordance Regulation I/9 of the STCW Convention.
- Australia, Austria, Azerbaijan, Brazil, Belgium, Bulgaria, Canada, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hong Kong, Hungary Iceland, India, Italy, Jamaica, Japan, Korea (Republic of), Latvia Lithuania, Luxembourg, Malta, Montenegro, Mauritius, Netherlands, New Zealand, Norway, Pakistan, Poland, Portugal, Republic of Ireland, Romania, Russian Federation, Serbia, Slovakia, Slovenia, South Africa, Spain, Sri Lanka, Sweden, Ukraine, Uruguay, United Kingdom, United States of America.
- 3.3 This list of countries may be updated from time to time by the reissue of this Shipping Notice.

3.4 Medical certificates should clearly state that they are issued by, or on behalf of, the Governments of the countries listed above. It is insufficient to hold a certificate issued by a doctor residing in the above countries if the certificate is not issued, by or on behalf of, the Government of that country.

## 4. PROFICIENCY IN ENGLISH LANGUAGE

- 4.1 It is a requirement that the officers on board a Cayman Islands ship, both at operational and management level, and irrespective of the common language of the ship, have an appropriate level of proficiency in the English language, commensurate with the functions the officer is permitted to perform.
- 4.2 Officers do not need to demonstrate proficiency in the English language if their CoC was issued by countries where "*Evidence of English is not required*" is indicated in the "Notes" section of the table in Section 2, above.

#### 5 KNOWLEDGE OF MARITIME LEGISLATION

- 5.1 Officers serving at the "management level" (masters, chief officers, chief engineers and second engineers) are required to have an appropriate knowledge of the maritime legislation of the Administration, relevant to the functions they are permitted to perform.
- 5.2 For officers on Cayman Islands ships this requirement is met by the officer demonstrating knowledge of Cayman Islands Laws and Administrative Procedures (LAP).
- 5.3 The Maritime Authority of the Cayman Islands (MACI) has launched a secure online distance learning and examination system for demonstrating the required knowledge of Cayman Islands LAP. This system forms part of MACI's Regulatory Intelligence System (CIRIS). Full details of CIRIS are available from <u>www.cishipping.com</u>.

#### 6. APPLYING FOR AN ENDORSEMENT ATTESTING THE RECOGNITION OF A COC

- 6.2 Completed applications and supporting documents can be sent to our offices in George Town (Cayman), Southampton (UK), Fort Lauderdale (USA) or Monaco.
- 6.3 When applying for endorsements, candidates should ensure that applications are complete in all respects and that copies of all required supporting documentation is included with the application.
- 6.4 Applicants should be aware that incomplete applications or missing supporting information can lead to lengthy delays in processing the application.
